Biographies

Aaron D. Rader is a Management and Program Analyst in the Education Branch at U.S. Citizenship and Immigration Services (USCIS). Mr. Rader is currently responsible for conducting outreach training events and seminars focusing on the Department of Homeland Security and the Social Security Administration's E-Verify program. His training experience includes employee training in Washington, DC, Dublin, Ireland, and Luton, England, as well as on-site security paperwork briefings and fingerprinting for freelance interpreters throughout the United States. Additionally, Mr. Rader uses his background in marketing to assist with planning media campaigns related to E-Verify, including pilot programs currently being tested in Arizona.

As a previous government contractor, Mr. Rader has worked on several immigration-related language services contracts with the Department of Justice's Executive Office for Immigration Review (EOIR) and

the Department of Homeland Security's USCIS Asylum Division. Prior to working on immigration issues, he taught English as a foreign language in Santa Cruz, Bolivia. Mr. Rader holds a B.A. in international relations from Roanoke College and a M.B.A. in business from Mount St. Mary's University.

Kevin Sibley is currently the Unit Chief for the Worksite Enforcement and Critical Infrastructure Protection Unit for U.S. Immigration and Customs Enforcement (ICE). In this position, he has programmatic and operational oversight of the national critical infrastructure protection, worksite enforcement, and IMAGE programs within the ICE Office of Investigations.

Prior to his current assignment, Mr. Sibley served as a National Program Manager in the ICE Headquarters Identity and Benefit Fraud Unit where he had programmatic oversight of nationwide investigations relating to fraudulent immigration applications, document fraud and identity theft. Mr. Sibley was responsible for drafting policy as a subject matter expert in the area of immigration fraud.

Before working at ICE Headquarters, Mr. Sibley was a Senior Special Agent in the ICE Benefit Fraud Unit Vermont (formally the Immigration and Naturalization Service Eastern Regional Office). While in Vermont, Agent Sibley was responsible for managing regional and national investigations involving human smuggling and trafficking, violent gangs, immigration benefit fraud and coordinating with the intelligence community. While in this capacity, Agent Sibley managed several nationwide initiatives relating to counter-terrorism in coordination with other Federal, State and local law enforcement and intelligence agencies.

Prior to his assignment as a Senior Special Agent, Mr. Sibley served as a Special Agent with the Immigration and Naturalization Service in the New York District Office, where he conducted large-scale immigration fraud, worksite enforcement and human smuggling investigations. Mr. Sibley was also responsible for conducting financial investigations in relation to criminal organizations engaged in human smuggling, trafficking and immigration fraud.

Agent Sibley began his career as a U.S. Border Patrol Agent in San Diego, California. After the Border Patrol, Mr. Sibley transferred to the position of Immigration Inspector at New York's John F. Kennedy Airport.

Mr. Sibley has an undergraduate degree in Legal Studies from the State University of New York at Buffalo.

Robin M. Stutman is presently Special Litigation Counsel in the Office of Special Counsel for Immigration Related Unfair Employment Practices, Civil Rights Division of the U.S. Department of Justice. The Office of Special Counsel enforces the anti-discrimination provisions of the Immigration and Nationality Act. Previously, Ms. Stutman was a litigator at the Washington, D.C. office of the law firm of Venable, Baetjer, Howard & Civiletti.

Prior to practicing at Venable, Ms. Stutman was a Trial Attorney in the Federal Programs Branch of the Civil Division of the Department of Justice, where she defended and enforced the programs and actions of various government agencies.

Ms. Stutman attended the State University of New York at Stony Brook, where she received her B.A. degree in Political Science. She then attended the University of California at Los Angeles School of Law, where she received her J.D. degree.

Ms. Stutman is a member of the District of Columbia Bar and the California State Bar. Most recently, Ms. Stutman successfully completed the U.S. Department of Justice's Senior Executive Service Candidate Development Program, and earned a Certificate of Executive Qualifications for the U.S. Government's Senior Executive Service.
